1. Appointment as Scrutinizer

We were appointed as the Scrutinizer by the Board of the Company at their Meeting held on **03rd September, 2025** for the remote e-voting as well as the e-voting by Members at the 40th Annual General Meeting ("AGM") ('poll') of Renewable Energy Systems Limited (hereinafter referred to as "the Company") held on Tuesday 30th September 2025 at 12:00 noon. (IST) through Video-Conferencing (VC)/ Other Audio Visual Means (OAVM). Our responsibility as a Scrutinizer was to ensure that the voting process was conducted in a fair and transparent manner and submit a Scrutinizer's report on the voting on the resolutions based on the reports generated from the electronic voting system at the Meeting.

2. Closure of Register of Members:

Pursuant to Section 91 of the Companies Act, 2013 and the Rules made thereunder, the Register of Members and Share Transfer Books of the Company shall remain closed from Wednesday 24th day of September, 2024 to Tuesday 30th day of September, 2025.

3. Dispatch of Notice convening the AGM

3.1. Pursuant to the relevant applicable provisions of the Companies Act, 2013 for holding the AGM, the advertisements were published in The South India Times (English) and Mana Telangana (Telugu) on 10th September 2025, specifying the date & time of the AGM, availability of the notice on the Company's website, manner of registration of email ids by the Members (both physical and demat) who are yet to register their email ids with the Company, manner of voting through remote e-voting or e-voting system at the AGM etc.

3.2. The Company has informed that based on the Register of Members and the list of Beneficial Owners made available by M/s. Purva Share Registry India Pvt Ltd., Registrar and Share Transfer Agents ("RTA") of the Company and the depositories viz., and Central Depository Services (India) Limited ("CDSL") respectively, the Company completed dispatch of Notice of 40th AGM and the Annual Report for the financial year 2024-25 on 03rd September, 2025 by e-mail to the Members who had registered their email ids with the Company/ Depositories.

4. Cut-off date

4.1 Voting rights with respect to the agenda items were reckoned as of Tuesday, September 23rd, 2025, being the cut-off date for the purpose of deciding the entitlement of Shareholders / Members for Remote e- voting and e-voting during the AGM





5. e-voting process

5.1. Agency

The Company appointed CDSL as the agency for providing the platform for e-voting.

5.2 Remote e-voting period

Remote e-voting platform was open Saturday, 27th September 2025 at 9:00 AM (IST) and ends on Monday, 29th September, 2025 at 5:00 PM (IST.), and Members were required to cast their votes electronically, conveying their assent or dissent in respect of the resolutions on the e-voting platform provided by CDSL e-voting.

6. Voting at AGM

6.1. In line with under Rule 20(4)(xiii) of the Companies (Management and Administration) Rules, 2014, for the purpose of ensuring that Members who have cast their votes through Remote e-voting do not vote again during the AGM, the Scrutinizer shall have access after the closure of period of Remote e-voting and before the start of the AGM, to only such details relating to Members who have cast their votes through remote e-voting, such as their names, DP ID & Client ID/folios, number of shares held but not the manner in which they have voted.

6.2. Accordingly, CDSL, the e-voting agency, provided us with the names, DP ID & Client ID/ folios, and shareholding of the Members who had cast their votes through remote e-voting.

7. Counting Process

7.1. On completion of the e-voting at the AGM, we unblocked the results of the e-voting by the Members, on the www.evotingindia.com e-voting platform and downloaded the results for scrutiny.

8. Results

8.1. Consolidated results on Remote e-voting and e-voting (poll) with respect to the agenda items as set out in the Notice of the 40th AGM dated 03rd September 2025 are enclosed herewith.
